The September 8, 2015 meeting was called to order by President Rogala at 6:30 PM.

Mission Statement read by member Bollech.

Principal's Report reviewed with Johnson. A new 45 gallon aquarium from Mare-Z-Doats for not over \$600.00 approved by MMS Soli and Bollech. The store will deliver and set up at school. A field trip will be set up later for students to pick out some fish for the new tank.

Drue to call Charlie Johnson in response to his letter of interest in doing maintenance work for the school using his own tools. One hour minimum at \$12.00 per hour. If supplies need to be picked up, he will be reimbursed for his mileage using the IRS rate.

B. Dickinson-Iron meals. Drue received an email and they are offering a hot meal for Monday, Tuesday, Wednesday and Thursday and include a cold lunch for Friday with the Thursday meal. On MMS Martin and Soli, our Board approves this plan.

New Business:

A. Groundskeeping discussed. 'Using the school's equipment would be \$55.00 for lawnmowing and weed whacking. Using your own mower and weed whacker \$70.00.

B. Snowplowing: The Township will be placing an ad in the L'Anse Sentinel for plowing of the access site.

C. The school owns a 2007 Cub Cadet which was purchased for \$1,495 from Pelkie Outdoors and was valued at \$650 by Glen with a minimum of \$500 (depending on condition).

E. Leadership Conference to be held September 25, 2015 at Magnuson Franklin in Houghton. Druce presented each Board member with the information. Board approved covering the cost of \$35 per attendee for the full day conference.
