The July 17, 2017 meeting was called to order by President Rogala at 6:30 PM.

Mission Statement read by member Bollech.

Members present were Fair, Rogala, Soli and Bollech, Absent Martin. Staff Newland, Drue and Johnson.

Agenda adopted by MMS Soli and Fair.

Minutes, June 29, 2017 Budget and Regular Board Meeting Minutes both approved by MMS Fair and Soli.

Visitors: Paul Skoglund of R&A Transportation of Iron Mountain. Mr Skoglund presented R&A's bid for the upcoming year at \$95,000.00/year. After discussion he was advised that we will contact R&A very soon of the Board's decision.

E. Reading over and signing of School Contracts. On MMS Soli and Fair to accept all Contracts as written and signed by President Rogala. All in favor.

New Business:

A. Lunch and milk prices discussed with Board members. On MMS Bollech and Fair for the full price lunch to remain at \$1.15 with reduced at .40 and milk at .15. All in favor.

B. School start date will be September 5, 2017.

D. Invoice for fence repair. Advised the bill is to be paid.
