The August 8, 2017 meeting was called to order by President Rogala at 6:30 PM.

Mission Statement read by member Bollech.

Members present were Fair, Martin, Rogala, Soli and Bollech. Staff Newland and Johnson.

Agenda adopted by MMS Fair and Soli.

Minutes of July 17, 2017 approved by MMS Soli and Fair.

Correspondence: Rukkila/Negro & Associates letter dated July 31, 2017 re their services to the Arvon Township School. The letter was signed by President Rogala and returned to Rukkila/Negro.

Principal's Report: Among items presented by Johnson, Baraga Telephone is installing optic cables for better internet service; Range Communications will be sending a quote for a wireless security system. A Student Handbook for 2017-18, including the bullying policy, required annually. Added to the Handbook is a early dismissal policy. Upon review and on MMS Martin and Fair the Student Handbook was approved. Also discussed the school's right to choose to close a grade to school of choice students. On MMS Martin and Fair the school will close to school of choice students for the 6<sup>th</sup> grade effective immediately. The school will advise the ISD in January 2018 for posting.

Finance Report: Newland reviewed the monthly statement and bills. Current liabilities and equity equals \$687,153.99. On MMS Bollech and Soli to accept the monthly statement and pay the bills. Ayes by Fair, Martin, Rogala, Soli and Bollech. Nays none.

- A. Bricks on back patio. After discussion, for this year, we will have Hollon use Sakrete to smooth over the low spots to bring the area level. In 2018 a decision will be made to correct the situation.
- B. Power wash the front of the School. Rogala to place ad in L'Anse Sentinel.

- C. Security System: We will be receiving a bid from Range Communitons after August 14<sup>th</sup>.
- D. L-4029 Certification of Millage Spread and Resolution Certifying Millage to be Spread reviewed by Newland. On MMS Bollech and Soli to adopt the L-4029 and Resolution certifying millage of 10 mills to be spread. Ayes by Martin, Fair, Soli, Rogala and Bollech. Nays none.
