Pledge of Allegiance.

President Terri Martin called the meeting to order at 6:00 PM.

Members present were: Martin, DeLine, Soli and Bollech. Absent Stiebe.

On MMS DeLine and Soli, Terri Martin was nominated for President. All in favor.

On MMS Soli and Martin, Heather Stiebe was nominated for Vice-President. All in favor.

On MMS Martin and Soli, Susan Bollech was nominated for Secretary. All in favor.

On MMS Bollech and DeLine, Nancy Soli was nominated for Treasurer. All in favor.

On MMS Martin and Bollech, Mary DeLine was nominated for Trustee. All in favor.

On MMS Martin and Soli, Board member pay shall be \$30.00 per meeting. The President shall receive an extra \$30.00 per meeting totaling \$60.00. The Secretary shall receive an extra \$55.00 per meeting totaling \$85.00 per meeting. The Treasurer shall receive an extra \$25.00 per meeting totaling \$55.00 per meeting. On MMS Soli and DeLine, the Auditor shall remain Rukkila/Negro. All in favor.

On MMS Bollech and Martin, the monthly meeting date shall remain the second Tuesday of each month at 6:30 PM. Any changes to be posted on the front door, as well as any special meeting date three (3) days prior to the meeting. All in favor.

On MMS Soli and DeLine, the mileage reimbursement rate shall be the same as the IRS rate. All in favor.

On MMS Martin and Soli, the copier/fax charges shall be 15 cents per page with your own paper and 20 cents per page with the school's paper. Fax charge will be 30 cents per page. All in favor.
