The November 12, 2019 meeting was called to order by President Martin at 6:30 PM.

Principal's Report: Johnson reviewed her report with the Board. Among other items, Johnson reported that the Parent/Teacher conferences held last Thursday were well attended. Also, our upcoming Christmas Program will be traditional and was given Board approval.

Finance Report: Newland reviewed the monthly statement and bills. Total liabilities and equity equals \$494,275.93. We will be making Budget adjustments in January. On MMS Soli and Bollech to accept the monthly statement and pay the bills. All ayes by Martin, Soli, Stiebe and Bollech. Nays none.

Old Business:

A. Scholarship (Donation Cans) Donations picked up by Martin and deposited into our Account.

C. Water Test Update: The lead testing showed 5.8 lead before flushing and .98 after flushing for five minutes. 15.0 is the legal limit.

Membrane cost of \$99 every 3 to 5 years. On MMS Martin and Bollech to have Wandel's install their quoted system. Soli to further investigate other schools water systems and will advise Arvon School before Wandel's installation. All in favor.
